To allow someone other than the registered owner(s) of the accounts to have full trading authority, please complete Sections 1-3 and read Sections 4-7. Trading authority on fiduciary accounts (estates, guardianships, etc.) is governed by state law. Generally, it may be delegated to a bank trust department or registered investment firm, unless otherwise specified in the legal documents. Please print the name(s) of the authorized agent(s) and have the agent(s) sign in Section 3. The registered owner(s) of the account(s) listed in Section 2 should sign in Section 3 and obtain a Medallion Signature Guarantee for each account owner. **Medallion Signature Guarantee:** An eligible guarantor is a domestic bank or trust company, securities broker/dealer, clearing agency or savings association that participates in a Medallion Program recognized by the Securities Transfer Agents Association. The three recognized medallion programs are the Securities Transfer Agents Medallion Program (known as STAMP), Stock Exchange Medallion Program (SEMP), and the Medallion Signature Program (MSP). A notarization from a notary public is NOT an acceptable substitute for a signature guarantee.

**4. Applicable Account(s)**

If the authorized agent wishes to purchase or sell Pax World Funds shares, Pax World is hereby authorized to accept the instructions of the authorized agent on behalf of the registered owner. This authorization shall be applicable to all mutual fund positions the registered owner holds in the accounts above and/or in the name of the registered owner on Pax World Funds.

**5. Effect of this Power**

The authorized agent may inquire in and trade in the registered owner’s account as specified herein and Pax World Funds is authorized to follow the instructions of the authorized agent. Such instructions shall be limited to purchase, sell orders, and redemptions relating to mutual funds provided the disbursement is made to the registered owner or to a pre-authorized bank account. Pax World Funds shall assume no responsibility for reviewing or monitoring any investment decision or activity of the authorizing agent. The registered owner hereby agrees to indemnify and hold Pax World Funds harmless from, and to pay Pax World Funds promptly upon demand for, any and all losses or financial obligations which may arise from the act or omissions of the authorized agent with respect to the accounts.

**6. Pax World Funds Retirement and Plan Accounts**

Notwithstanding the aforementioned, however, if this trading authorization applies to an account number which contains a retirement account (“plan”) for which BNY Mellon Investment Servicing Trust Company or its affiliate and/or any successor acts as trustee or custodian, this authorization shall allow the authorized agent to provide instructions to Pax World Funds to execute such directions with respect to the plan(s). Such directions shall be limited to purchase and sell orders in any investment permitted by the terms of the plan(s), and any other incidental transactions so long as they do not result in a distribution from the plan(s), with the further exception that the authorized agent shall have no authority to designate beneficiary(ies) or establish a new plan, which are actions that must be done personally by the registered owner. It is understood that the consent of the employer must be obtained if this trading authorization involves a plan account in which the registered owner is a participant but is not the employer; however, Pax World Funds will in no way be responsible for the registered owner’s failure to properly obtain such consent. It is also understood that with respect to the registered owner’s plan(s). BNY Mellon Investment Servicing Trust Company merely acts as custodian or trustee, and has no discretionary fiduciary authority or responsibility. Accordingly, the suitability of any investments or actions which the authorized agent may direct, and any adverse consequences arising from such an investment or action, including, without limitation, the generation of unrelated business taxable income, is the sole and ultimate responsibility of the registered owner.

**Employer Consent (Required by a Plan for which BNY Mellon Investment Servicing Trust Company acts a custodian or trustee):**

**7. Duration of Authorization and Applicable Law**

This authorization is a continuing one and shall remain in full force and effect until Pax World Funds is notified in writing of death, disability, or incapacity of the registered owner or unless revoked through written notice delivered to Pax World Funds. Such revocation, however, shall not affect any prior liability in any way resulting from any transactions initiated before receipt of the revocation. Furthermore, it is understood this authorization and indemnity is in addition to and in no way restricts any rights which may exist at law or under any other agreement(s) between the registered owner and Pax World Funds. This authorization and indemnity shall be construed, administered, and enforced according to the laws of the Commonwealth of Massachusetts, and shall inure to the benefit of Pax World Funds and of any successor firm or firms irrespective of any change(s) at any time in the personnel thereof for any cause whatsoever, and to the benefit of the affiliates and the assigns of Pax World Funds or any successor firm.
