- The Fund will invest globally on an opportunistic basis

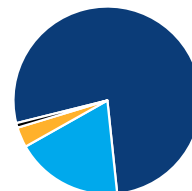

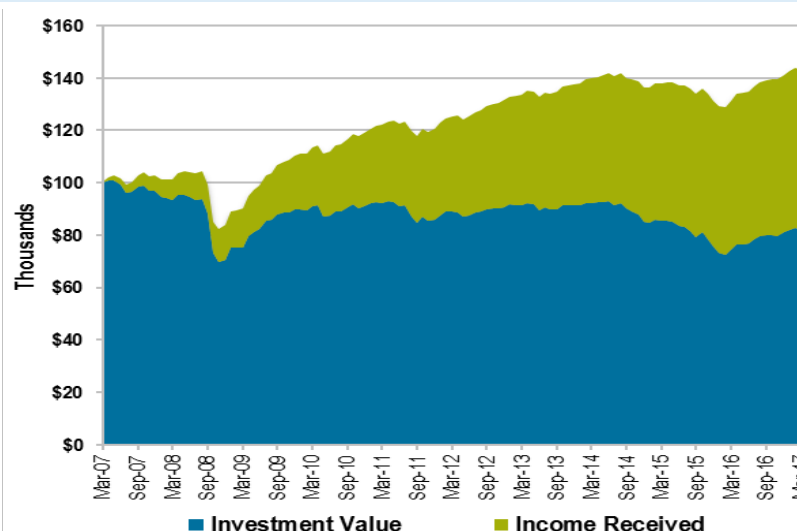

<sup>2</sup>Years to Maturity (weighted average) is the number of years until the bond matures and/or expires.

<sup>3</sup>Standard Deviation measures a fund's variation around its mean performance; a high standard deviation implies greater volatility.

<sup>4</sup>Beta reflects the sensitivity of a fund's return to fluctuations in its benchmark: a beta for a benchmark is 1.00. A beta greater than 1.00 indicates above average volatility and risk.

<sup>5</sup>Alpha is a coefficient measuring risk-adjusted performance, considering the risk due to the specific security, rather than the overall market. A positive alpha reflects relative risk-adjusted performance of a fund versus its benchmark.

<sup>6</sup>R-Squared is a measure of how much a portfolio's performance can be explained by the returns from the overall market (or a benchmark index). The measure ranges from 0, which means that a fund's performance bears no relationship to the performance of the benchmark, to 100, which means that a fund's performance is perfectly synchronized with the performance of the benchmark.

<sup>x</sup>The BofA Merrill Lynch U.S. High Yield BB-B (Constrained 2%) index ("Benchmark") tracks the performance of BB- and B-rated fixed income securities publicly issued in the major domestic or eurobond markets, with total index allocation to an individual issuer limited to 2%. 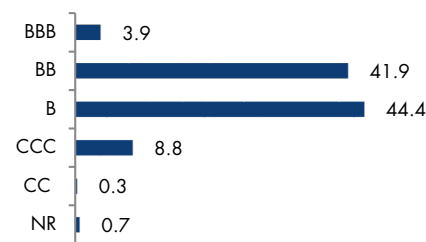
